Toniq Configuration

Dispensary: Standard Price Parameters (7,1,4)

- NSS and OTC margins and fees setup as required.
 TIP: these are applied to all medicines at time of dispensing, unless manually added direct to medicines. To save time updating medicines, you should use the Standard Price Parameters to apply container fees and markups.
- GST on 2nd page = 0.00% Toniq Retail will add VAT to OTC (R) prescriptions

Retail: Store Config (7,1,7,1, select store, F11 2nd page)

- Default tax label : VAT15 (D)
- Default Rx tax label (P) : VAT (B)

Processing (P) Scripts

• Process prescribed medicines from a doctor as (P)

Processing (P) Scripts with Repeats

- P scripts can include repeats, which can be dispensed when the patient returns
- Enter number of additional dispensing's required and the days they must be dispensed within. Example shows 2 repeats can be collected, and they must be picked up within 90 days of original.
- Issuing a repeat: Select patient, [F5 History Grid] Highlight the medicine line form history, [F5 Repeat], [F11 Accept], complete dispensing as required.



Retail (P) Scripts as 0% VAT

• P scripts when unparked into Toniq Retail, will show as **NoGST** on the sale screen



Processing (R) Scripts (refills)

- Process refills using script code R (as per normal process)
- We recommend refills are recorded against actual patient, so patient's medication history is all recorded/kept for easy referral and lookup, as well as important medication interaction checks

- There is no indication from the F4 Unpark list if a script was P or R script coded.
- All values will show what WILL be charged to the customer/patient
